Fellow Officers and Spouses,

Many of us got to participate in the 50th Vietnam Veterans commemoration at the Virginia Beach Convention Center. Our own John Uhrin organized the program and did an outstanding job representing the Hampton Roads Chapter of MOAA! We gathered to honor American Heroes - men and women who placed their lives on hold to defend their country at a difficult and dangerous time in the existence of the United States and the world. The Cold War raged across the world and a communist nation moved to subsume their neighbor in a far-off land called Vietnam. The tribute honored those

who served in Vietnam, those who served elsewhere during those dangerous times, and their families. Sadly, we as a nation did a poor job in honoring the men and women who served during that turbulent time. Most were told by their leaders not to wear their uniforms in public. Some were accosted and spit upon. The program put on by John hoped to remedy the sting of that period. These are, and were, honorable men and women who deserved better. Well done John, in honoring our nation's overlooked hero's!

Our nation has been at war in the War of Terror for over sixteen years. Because of prolonged deployments, multiple deployments, and the stresses of war over twenty active and veteran service members commit suicide each day across the United States. The VA and others in the medical profession consider this issue a national "public health issue" that requires a national approach. Congressional action is needed to get more mental health professionals into the VA and to enhance awareness among doctors across the nation. Aggressive efforts are needed to identify those at risk, provide effective treatments, and to develop strategic partnerships to help reduce this national problem. MOAA members can help through continued support for congressional action to mitigate this crisis.

During the past year I have been amazed at the support our Chapter has given to veterans. From support to veterans that served in World War II in helping them be honored to visit their memorial in Washington DC to providing support in helping homeless veterans in our cities, we have done a magnificent job. November is the month of veterans and I am proud of our support to those who have given so much. It is often said about our nations veterans, "some gave all, all gave some." Each of you makes me proud to be a member of our Chapter!

God Bless you all, our Service members, and the United States of America.

Legislative Affairs - Fall 2017 Update

CDR Linc Smith, USNR (Ret) Legislative Affairs Committee Chair

The purpose of this article is threefold. First, provide a brief update regarding our chapter legislative activity for 2017. Second, highlight MOAA's top legislative priorities before the Congress relating to our military. Finally, present an ongoing chapter wide request regarding legislative affairs.

Activity



In the Legislative Affairs Committee <u>presentation posted on our chapter website</u>, legislative engagement remains a key theme. In this vein, 2017 has been a year of legislative engagement for our chapter. In start, General McLaren and CDR Smith traveled to Richmond for the Virginia Council of Chapters (VCOC) annual "storming" of the hill in the Virginia General Assembly Building. We personally connected with the newest delegate from the Virginia Beach Delegation, Delegate Rocky Holcomb (R-85th).

In the Spring, CDR Smith represented the chapter at the 33rd Annual VCOC Congressional Appreciation Luncheon, at which VCOC President COL Steve Turner (USAF, Ret) presented Representative Barbara Comstock (VA-10th) with the Legislator of the Year award.

Our chapter luncheons this year have included Delegates Barry Knight (R-81st) and Rocky Holcomb (R-85th) speaking to our chapter for the Spring Legislative Luncheon. For our Fall Legislative Luncheon, newly elected Representative Scott Taylor (VA-2nd) spoke to our chapter. Legislative Priorities



The top MOAA national legislative priorities for 2017 have focused on two key issues. First ending "sequestration." Second, eliminating the Widows' Tax, more officially known as SBP/DIC OFF-SET.

In 2011, Congress passed "The Budget Control Act of 2011 (BCA)." The purpose of the BCA has been to establish automatic budget reductions, better known as "sequestration." This act established automatic budget cuts, addressing the inability of the Congress and Administration to mutually agree on Budget Deficit measures. In December of 2011, then Secretary of Defense Leon Panetta told the congress that the "meat axe" approach of sequestration would "hollow the military force." Secretary Panetta's predictions have not been incorrect. Each of the armed services continues to face significant readiness issues, both in terms of both manning and equipment, as a result of sequestration.

Each year, some 63,000 survivors of military members dying from service related conditions are penalized up to \$12,000 by the Widows' Tax. In sum, the SBP/DIC OFF-SET subtracts from the Survivor Benefit Plan survivors are receiving. Several years ago, Congress did address this inequity with a "Special Survivor Indemnity Allowance," currently funded at \$310 per month. However, this nominal allowance is set to expire in June 2018.

First, everyone an advocate. Each member of our chapter is, in effect, a MOAA legislative affairs advocate – no matter who you are or what you may believe. Write a letter. Pick up the phone. Send an e-mail. The formats for so doing with our legislators are located in the MOAA National Website legislative affairs section, along with the pertinent contact information.

Second, we need them all. No matter what the member political affiliation or level, our local district, congressional or national level legislators have both influence and power. So do their staffs. And they do listen, eager to hear the unvarnished truth from the deck plates.

Not too long ago, I encountered one of the Virginia Delegation staffers on the street at Town Center, Virginia Beach. Amidst no formal appointment, did I ask for some on the spot time? You bet. The result? A great cup of coffee, further relationship building and a conversation which included emphasis on the need to end sequestration – right now. It was another opportunity make our voice heard. Virginia Beach Vietnam Veterans 50th Anniversary Commemoration CDR John Uhrin, III, USN (Ret)

Virginia Beach Vietnam Veterans 50th Anniversary Commemoration turned out to be an exceptional event that honored the Virginia Beach veterans, spouses and families from the Vietnam era. Those folks faced different conditions than today's military veteran. This special reception and ceremony held on November 12th at the Virginia Beach Convention Center Ballroom honored 550 veterans and their families. There were special honor certificates and pins given to the immediate families of those veterans whose names are engraved on the Vietnam Memorial in Washington, DC as well as to the surviving spouses of those veterans who have passed away since the Vietnam war.



The ceremony was opened with the parading of the colors with the five services flags and a soloist from the Armed Forces Band singing the National Anthem. The chaplain gave a nice opening prayer which was followed by a welcome by the Mayor of Virginia Beach, Will Sessoms. The main speakers were RADM John Scorby Commander Mid-Atlantic Naval Region and the Keynote speaker, Congressman Scott Taylor.

The feedback we have received to date is extremely positive. Hampton Roads Chapter of MOAA should be rightfully proud of the partnership with DoD which made this event possible and gave these veterans the recognition they deserve for their service.

Besides the key partnership with DoD, our chapter helped in organizing other key participants such as the NJROTC Color Guard and the ROTC and NJROTC cadets and midshipmen that checked in the 500 plus attendees. Special thanks go to our president, MGEN John McLaren who stepped up and did a superb job as the EMCEE. There were many other HRCMOAA members who helped in making this event a success: Barbara Smith, Doug Williams, Mike Barea, Jim Daniels, Chris Mayfield, Clif Furedy, Jim Smith and Jim Jones. Besides the members who helped, some of our wives and friends also helped during the event. A warm "THANK YOU" to all those that were so instrumental in guiding this commemoration to such a grand finale.

Military ID Card Notification Program

This voluntary program is designed to help Chapter members and their dependent's to renew their ID cards in a timely fashion. Once you and your dependents are enrolled, you will be notified of your impending ID card expiration date in sufficient time for renewal prior to the expiration date.

To enroll by mail: make copies of the form below for each dependent and fill out the required information. Mail to Military ID Card Notification Program, HRCMOAA, PO Box 4612, Virginia Beach, VA 23454-0612.

To enroll by email: visit our website, www.hrcmoaa.org and click on About Our Chapter and the ID Card Notification Program link and follow the instructions.

Note: Over age 75 members, who are eligible uniform family members and survivors of deceased personnel are now eligible for Permanent Identification Cards. Apply within 90 days of expiration of current ID card.

Veterans Day (Chesapeake, VA)

The Mayor's Commission on Veterans Affairs Chesapeake hosted the annual Veteran's Day Ceremony on Saturday, 11 November at the Veteran's Memorial in front of City Hall. Over 200 veterans, families and friends attended. Chesapeake Mayor Dr. Alan P. Krasnoff hosted CAPT Brandon Lechthaler, USCG as the featured speaker. CAPT Lechthaler serves as Commander, Maritime Security Force Response Team.

This year, the ceremony included the official dedication of names on the Soldiers Cross, along with the placing of four plaques in honor of veterans from both the Vietnam War and World War Two eras. Commissioner Linc Smith (USNR Ret) acted as Master of Ceremonies, with music provided by the Grassfield High School Band, and the United States Marine Corps Security Forces Training Company acting as honor guard.





Congressman Taylor Speaks At Chapter Luncheon *CDR Linc Smith, USNR (Ret)*

As part of the Chapter Congressional Affairs Program, Congressman Scott Taylor (VA - 2nd District) was the featured speaker at our Chapter Luncheon on September 15. Assuming office on 3 January 2017, Congressman Taylor is a member of the House Appropriations Committee.

Additionally, he serves on over twenty caucuses, to include that of the Air Force, Army, Coast Guard, and Navy and Marine Corps. A former Navy Seal for eight years, the Congressman served in South and Central America in counter narcotics missions and as a sniper during Operation Iraqi Freedom.

During his address to the chapter, Congressman Taylor spoke about his strong advocacy for Veterans benefits, the National Security of the United States and an update on how his first term in Congress is progressing. He indicated that his own personal health care is with the Veterans Administration. Of note, the Congressman emphasized his accessibility at all times, with emphasis on assisting constituents experiencing difficulty with any Federal Agency.

Not long after our chapter luncheon, Congressman Taylor voted to pass the Department of Veterans Affairs Expiring Authorities Act, saying "Our district has the fastest-growing veterans population in the country…passing this legislation means that veterans can rest easy knowing they will continue to have access to vital programs that support their health and the wellbeing of their families. I want to thank Representative Mast and the members of the Veterans Affairs Committee for their hard work and leadership on this bill."


