

Legislative Affairs Update

CDR Linc Smith, USNR (Ret)

The purpose of this article is to briefly highlight two key legislative events occurring in January this year, and remind our Chapter members of the online MOAA Legislative Action Center. In regards to the two events, first - the Virginia Joint Leadership Council (JLC) Day, which occurred at Capitol Hill in Richmond on January 16. Second - the Annual Commonwealth Coffee honoring Virginia Veterans, held January 17, Room 106 Dirksen Senate Office Building, Washington, DC.

JLC Day



VCOC was one of several service organizations participating in JLC Day this year in Richmond. Primary goals of JLC Day 2019 included increasing visibility and credibility of the JLC and its role as advocate for Virginia Veterans, educate new legislators on the mission of JLC and continue to build strong relationships with both Virginia Delegates and Senators.

In this vein, I joined LTCOL John Down (USAF, Ret.), Legislative Chair of the MOAA Central Virginia Chapter, in a mid morning visit with Senator Bill DeSteph (R 8th), to discuss the seven JLC Legislative Initiatives for 2019, with focus on Electronic Ballot Return by Overseas Military (JLC 2019-03). The recommendation of this initiative is that the Governor provide budget support of \$100,000 for a pilot program at the Virginia State Board of Elections for the return of absentee ballots by Virginia's deployed military service members. Senator DeSteph is co-patron for this bill.

Commonwealth Coffee

Sponsored by Senators Tim Kaine and Mark Warner, the Commonwealth Coffee honoring Virginia Veterans is not a MOAA event. This noted, a number of MOAA members, both at the chapter and national level, attended this year. Virginia Veterans of multiple generations and services, both active duty and retired, were present. Both Senators emphasized the critical importance of ensuring bipartisan support and delivery of a national defense bill which advances our nation's security, supports our active duty service members, and provides the resources necessary to keep our nation safe.



During the coffee this year, I spoke with Mike Henry, current Chief of Staff for Senator Kaine, regarding the ongoing concurrent receipt of Veterans benefits. A top priority of MOAA Legislative Affairs for 2019, the goal is for Congress to fully eliminate the law that makes most disabled uniformed services retirees forfeit part or all of their military retired pay for VA disability compensation. This voluntary program is designed to Chapter members and their help dependent's to renew their ID cards in a timely fashion. Once you and your dependents are enrolled, you will be notified of your impending ID card expiration date in sufficient time for renewal prior to the expiration date.

To enroll by mail: make copies of the form below for each dependent and fill out the required information. Mail to Military ID Card Notification Program, HRCMOAA, PO Box 4612, Virginia Beach, VA 23454-0612.

Note: Over age 75 members, who are eligible uniform family members and survivors of deceased personnel are now eligible for Permanent Identification Cards. Apply within 90 days of expiration of current ID card.

Fall Commission Ceremony

The Hampton Roads Naval ROTC Fall Commissioning Ceremony was held on Friday December 14, 2018 at 7pm. The ceremony was held in the Old Dominion University (ODU) Goode University Theater. Despite the rainy and windy weather the event was well attended by family, friends, fellow service members and colleagues. The next generation of Naval and Marines Corps leaders were individually commissioned on stage with immediate family alongside. Active duty service members, family members who were retired service members made their way up on stage to render the "First Salute". The ceremony this year was smaller than in the past. The Naval Service ROTC Unit commissioned three Ensigns in the Navy and two Second Lieutenants in the United States Marine Corps. The ceremony was hosted by CAPT Lennie Reed, USN, Commanding Officer/Professor of Naval Science. The ceremony started with a student's solo performance of the National Anthem that was very moving resulting in a number of emotional displays in the audience.

University Officials from Regent University and Old Dominion University addressed the audience and HRCMOAA's Board of Director, CAPT Mike "Breeze" Barea, USN (Ret) was in attendance. CAPT Barea presented newly commissioned officers with a set of Gold Bars and congratulatory letters following first salutes rendered. The Guest Speaker was CAPT Robert E. Clark, Jr., USN (Ret), ODU's Director of Military Activities and Special Projects. CAPT Clark is a 1989 ODU graduate earning a degree in mechanical engineering. His career included a First Division Officer tour as a member of the last crew to serve in USS Wisconsin (BB 64). He later commanded USS Mason (DDG 87) and then became Operations Officer with the George HW Bush Carrier Strike Group (CSG 2). He went on to become the Commanding Officer of Naval Station Norfolk, the free world's largest Naval Base where he later retired. CAPT Clark once served as Grand Marshal for ODU's Homecoming Parade.

Virginia Council of Chapters (VCOC) Update

"The Virginia Council of Chapters (VCOC) met 15 January 2019 in Richmond at the American Legion Headquarters. Several important issues were addressed. Among them were:

1. Efforts are being made by the Administration, DOD and Congress to reduce the cost of TRICARE, including TRICARE FOR LIFE. Among the contemplated changes are enrollment fees and cost sharing. MOAA is challenging such efforts, but needs members to contact Congressmen and Administration officials to support those efforts. An effective way to go to the MOAA website (www.moaa.org) and enroll in the MOAA Newsletter. The Newsletter is a members-only e-newsletter which provides information on a range of topics most important to you. The Newsletter includes legislative issues involving you and your bene-fits; up to date information on TRICARE and VA benefits; financial advice and guidance; transition and career information; and gives you access to a MOAA Newsletter. Once in the Newsletter, go to the Take Action dropdown to see the issues that are most timely and which provides you with a draft message you can email to your Senators and Representatives.

Once you have registered in the MOAA Newsletter, you will receive regular emails bring you up to date on important issues, and an opportunity to continue to send an email message to your Congressmen.

If you are not now a email subscriber to the MOAA Newsletter, do it now; its important!

2. MOAA's "Storming of the Hill" in Washington, DC is scheduled for the second week in April 2019. Contact CDR Linc Smith or COL Jim Smith for more information. This is another opportunity to get your voice heard on issues important to you.

3. The next VCOC meeting is scheduled for 3 April 2019 at the American Legion Headquarters in Richmond. The rest of the quarterly meetings are scheduled for 17 July and 9 October 2019 at the Virginia American Legion Headquarters. Those interested in attending or learning more about the VCOC, its mission, and how it supports MOAA and our Chapter may contact Colonel Jim Smith at (757) 425-5934.

4. MOAA is conducting a one-day (1000-1400) Leadership Training session intended for both emerging and potential leaders in the Virginia Chapters. 

FROM MOAA.ORG: SPOUSE AND FAMILY NEW LAW AFFECTS MILITARY SPOUSE VOTING, TAXES, AND LICENSURE By: *Eryn Wagnon*

Military spouses now can choose to take their servicemember's state of legal residency without having physical presence in the state, thanks to a law signed by the president on New Year's Eve.

The Veterans Benefits and Transition Act of 2018, sponsored by Sen. Jon Tester (D-Mont.), rolled together a number of individual bills that had been referred to the Senate and House Veterans' Affairs Committees, including H.R. 282 - the Military Residency Choice Act, which was introduced by Rep. Elise Stefanik (R-N.Y.) in January 2017.

MOAA has supported this provision since its inception, actively educating members of Congress and government officials on the benefits of such a law. In March, MOAA submitted a statement for the record to the House and Senate Veterans' Affairs Committees outlining our support for the then-bill.

Previously, only military spouses who shared the same state of legal residence with their servicemember were protected from changing their residency every PCS. The new law allows for military spouses to take their servicemember spouse's state of legal residency for voting and tax purposes regardless of their date of marriage and physical location essentially inheriting their servicemember's residency, if they so choose.

Not only does this law benefit military spouses for tax and voting purposes, but it is useful for military spouses who have occupations that require state licenses. Changing state residency every PCS means that spouses have to change their state license to match their new residence. The cost and time to complete relicensing negatively impacts the employability of a military spouse. Allowing a spouse to maintain one residence during their servicemember's time in the military prevents the headache of getting relicensed and makes it easier to operate within interstate compacts for occupational licensure.

In her testimony to the House Veterans' Affairs Subcommittee on Economic Opportunity, Stefanik emphasizes the importance of this change: "Military spouses serve too, and this piece of legislation eliminates the daunting task of documenting multiple tax jurisdictions, which at times causes some spouses to forego the complication of working altogether. ... This common-sense legislation will make this easier for military spouses to work, and help reduce instances of military spousal unemployment."


