

Beware of Scams Connected to the Coronavirus Crisis

In a time of uncertainty, there is a heightened risk of falling victim to scams concocted by those with ill intent. For cybercriminals and scammers, the coronavirus crisis creates an attentive audience who may be willing to accept false information to protect themselves.

Arm yourself not only against the virus, but against other threats, by learning how to detect them first with tips from the Army Criminal Investigation Command (CID).

Knowing how legitimate organizations do business can give you a leg up on anyone who attempts to pull the wool over your eyes.

As always, follow good practices online and don't open or click on links from unsolicited emails. These links or emails could contain malware. Never give away personal or financial information about yourself or others online without first verifying the source.

Most scams include messaging that require immediate action. No matter how urgent it sounds, if something doesn't sound quite right, it probably isn't, and you can always contact an organization you know and trust for confirmation. Legitimate organizations can verify their information and will not pressure you into taking an action that you are uncomfortable with.

Seeking information from trusted sources can also help you steer clear of scams. MOAA has links to these organizations, as well as links for recent



Community Affairs - Hampton Roads Chapter ROTC Scholarship Fund

This past year, several of your HRCMOAA board members met with Ms. Andrea Rand, the director of the MOAA Scholarship program to request some changes to how scholarships in our chapter name were being awarded. As a result of our suggestions and input, the MOAA Scholarship Fund Board has agreed to make several important changes. Beginning with the 2020-2021 school year, the MOAA Scholarship Fund Board will give preference in awarding scholarships and grants to children with HRCMOAA chapter member parents. While not guaranteed to go to the child of a chapter member, those children applying for MOAA scholarships with a parent who is a chapter member will receive favorable consideration and the review board will give preference in awarding scholarships to those children. Regardless of whether the student's parent is a chapter member or not, students selected for MOAA scholarships in the chapter name will always be from the area represented by our Hampton Roads Chapter. Below is the status of our chapter scholarship fund both for this year and overall for the 5-year goal.

EMERGENCY/SURVIVOR CORNER - PART IV

The last article continued the processes you must use to get "into the vast system." This is edition 4 of 4. Let's get into some more of the details significant for you to be able to quickly and efficiently navigate the bureaucracy that goes with dealing with the government and other entities at all levels.

Check in safes, safety deposit boxes, leave and earning statements, and civilian pay stubs for insurance policies. Many of these policies are underwritten by a variety of insurance providers. Each will have to be contacted. You as the survivor and in most cases beneficiary, must meet the policy's specific requirements for proof that the terms of the policy are applicable. Many insurance providers will require a copy of a death certificate and perhaps other data on the person that has passed.

Contact should be made with all fraternal organizations the person who has passed belonged to during their lifetime. Some organizations provide benefits and as a survivor you may be able to retain those benefits. It is always a good practice to check with them to see about benefits and to notify them of the person's passing.

Notification of insurance companies for home, automobile, trailer, RV, and boat policies is a must. If there is a survivor, the names of those that passed needs to be removed from the policy. Also, if there is not a survivor, some states require insurance coverage until the asset is sold by the executor.

Finally, dealing with credit cards and, more importantly, ensuring the cards are properly disposed and the accounts are closed is financially wise. Typically waiting until the last billing cycle is over is prudent. Once the billing cycle has been completed and balances paid off, contact Equifax at (888) 548-7878. They will put a lock on all credit attempts under the person's name who has passed. This requires, in the end, a letter to Equifax. This letter will contain information Equifax will tell you to provide, and a copy of the death certificate. Once they send you a letter saying the cards in the deceased's name have been locked you can contact all the outstanding credit card companies and close the accounts or modify joint accounts to drop the deceased's name. Some will let you close them by phone, others will require a letter and a copy of the death certificate.

We earnestly hope this helps you in navigation of the process on the passing of your loved one. As we said at the beginning it does not cover everything and never could. Each family, survivor, or executor takes on this process knowing there are many branches and sequels to resolution. We wish you all the best in your journey and stand ready to assist in any way possible.

SPRING 2020 LEGISLATIVE AFFAIRS UPDATE

CDR Linc Smith, USNR (Ret.), Chair HRCMOAA Legislative Affairs Committee

Our chapter legislative affairs program is underway at full speed ahead for 2020. In concert with such speed, the purpose of this article is threefold. First, highlight events significant to our legislative affairs program so far this year. Next, present a "look ahead" at forthcoming events. Finally, provide a brief reflection, with closing.

Events

As of this writing, four events this year have been most significant to our chapter legislative affairs program.

First, along with fellow Virginia Council of Chapters members, I participated in Joint Leadership Council Day in Richmond, 15 January 2020. Our team advocated for six JLC legislative Initiatives, seen on the Department of Veterans Services homepage at: https://www.dvs.virginia.gov/dvs/joint-leadership-council-veterans-service-organizations-2

At the conclusion of the Virginia Legislative Session 2020, status of the JLC initiatives are as follows:

Three initiatives passed both the House and Senate: JLC 2020-01: Second Resolution - Personal Property Tax Exemption, JLC 2020-04, Virginia National Guard Emergency Response Pay and JLC 2020-05: Tax Credits for Employers who Hire Virginia National Guard and Reserves. Note that JLC 2020-01 will be on the 3 November ballot this year.

Two JLC initiatives are continued until 2021: JLC 2020-02, Counting Military Absentee Ballots After Election Day and JLC 2020-03, Income Tax Subtraction for Certain Low Income Disabled Veterans.

Don't forget our ID Card Renewal Notification program. You can register the expiration of your ID card and the ID card for family members with Captain Jim Daniels on our chapter website. Here's the link to go right to the information about the program:

If you have any difficulty, you can find it by clicking on the "About Our Chapter" link on the left hand side. Once you click on "About Our Chapter", you will see a drop down listing on the left hand side that shows "ID Card Notification Program" or you can just scroll to the bottom of the page. This shows the information about the program. Then there is a graphic link to a page where you can fill in information and it will be sent to Captain Daniels who keeps the data on when renewals are due. There is a link to the registration form and you have to type in the code word shown on the page to jump to that form. You can also contact Captain Daniels via email at jakaoc@aol.com to register for your renewal notification.

Finally, I would ask that you share your Tribute newsletter and monthly post card invitations with potential members in your neighborhood and other organizations you participate in. The best recruiters of new members are our current members and the best way to get a new member is through a personal contact. Military ID Card Notification Program

This voluntary program is designed to help Chapter members and their dependent's to renew their ID cards in a timely fashion. Once you and your dependents are enrolled, you will be notified of your impending ID card expiration date in sufficient time for renewal prior to the expiration date.

To enroll by mail: make copies of the form below for each dependent and fill out the required information. Mail to Military ID Card Notification Program, HRCMOAA, PO Box 4612, Virginia Beach, VA 23454-0612.

To enroll by email: visit our website, www.hrcmoaa.org and click on About Our Chapter and the ID Card Notification Program link and follow the instructions.

Note: Over age 75 members, who are eligible uniform family members and survivors of deceased personnel are now eligible for Permanent Identification Cards. Apply within 90 days of expiration of current ID card.

The **first** way is for members to submit their donations online by utilizing the following website URL (Although the chapter is not an input on that page, MOAA will credit the contribution to the chapter utilizing your name and address): https://ebiz.moaa.org/PersonifyEbusiness/ Default.aspx?TabId=171

The **second** way is to submit a check, made out to the MOAA Scholar-ship Fund and mail it to:

Note on your check that it is for the Hampton Roads Chapter ROTC Scholarship Fund. MOAA will continue to send receipts.

A **third** way is to contribute directly from bequests, wills, trusts, or IRA's. The fund tax identification number is 54-1659039. By contributing from the Required Minimum Distribution (RMD) of a qualified IRA, the taxable IRA income can be reduced by the amount of the contribution. The contribution check must be marked as a charitable contribution. With the change in the tax laws last year, some of our members have found this method to be beneficial. For additional detail, it would be best to contact your IRA fund manager for specifics relating to your IRA.

JLC 2020-06, Microloans for Veterans Program, passed the Senate. However, the bill was left in Appropriations, as the required funds were not part of the final budget.

Second, the celebration reception of the "Widows Tax" elimination, held Wednesday, 5 February, U.S. Capitol Visitor Center, DC, for which MOAA was one of five sponsors. The purpose of the reception was to celebrate the repeal the SBP DIC Offset "Widows Tax," now passed as part of NDAA 2020.

Previous to the SBP DIC Offset Congressional Celebration, MOAA President and CEO Lt. Gen. Dana Atkins said, "The 116th Congress has an opportunity to be known for getting this done."

In a previous release, Representative Joe Wilson, (SC-2nd) who with Sen. Bill Nelson (D-Fla) introduced legislation (H.R. 846 and S. 339) to repeal the "Widows Tax" said, "It is unconscionable to think there is a 'Widows Tax' on the surviving family members of our fallen heroes....We owe it to them to secure stable benefits in the event of their retirement or death."

Third, the Virginia Military Caucus Military Appreciation Night, Thursday, Feb. 27, Virginia War Memorial Lobby, Richmond. Hosted by the Military Caucus and Caucus Co-Chair Senator Bryce Reeves (R-17th), I served as Master of Ceremonies. Catered by Mission Barbecue, the evening was well attended, to include by Virginia service organization members, elected officials and Veterans. Virginia Lieutenant Governor Justin Fairfax, Commander, Virginia National Guard Maj. Gen. Tim Williams, USA, Secretary of Veterans and Defense Affairs Carlos Hopkins and Department of Veterans Services Commissioner John Maxwell were among those who spoke.

Finally, I represented HRCMOAA during the testimony of MOAA Senior Director, Government Relations CDR Rene Campos, USNR (Ret) at the Senate Veterans Affairs Committee and House Veterans Affairs Committee Joint Hearing, 3 March 2020, Dirksen Senate Office Building, Committee on Rules and Administration Event Room, DC. CDR Campos testimony included highlight of both the VA Mission Act and MOAA legislative priorities for 2020.

Looking Ahead

The MOAA National Council Presidents' Seminar scheduled for March 23 - 26, 2020, Washington DC, which includes the annual "Storming of the Hill," has been cancelled due to the COVID-19 virus outbreak. MOAA CEO and President Lt. Gen. Dan Atkins, says, "In view of guidance from the Centers for Disease Control and the U.S. Office of Personnel Management, MOAA is cancelling its annual Storming the Hill campaign..." In lieu of storming, "we will employ an engagement strategy that hinges on calls to action by all of our members." MOAA asks Chapters to "get appointments to see their members of Congress during some upcoming scheduled breaks this spring."

Reflection and Closing

In reflection, this brief article closes with the selected thoughts from two former military officers.

First, from the late Senator John H. Chafee (R RI). He once said, "You need the House, you need the Senate and you need the administration. And absent one of them, you're not going to get a heck of a lot done." Senator Chafee served as an officer in the United States Marine Corps, World War II (Guadalcanal and Battle of Okinawa) and in the Korean War (Battle of Chosin Reservoir). He also served as the 66th Governor of Rhode Island, Secretary of the Navy, and as a United States Senator.

Next, the March 2020 issue of MOAA Magazine features an article (p.94) entitled, "Advocating at the State Level." In the article, Texas Council of Chapters President Maj. James Cunningham, USA (Ret) says, "Take the time to really develop hard and fast relationships with your elected officials. I'm not talking about calling them once a year. Go to their offices once a month. Get together for a meal, so you really get to know your elected officials. That's the most effective way to have them pay attention to you, especially when you're giving them information that is valuable and helps them serve their electorate."

In the spirit of the words of Senator Johnny Chafee or the counsel of Maj. Jim Cunningham, HRCMOAA Legislative Affairs will continue to engage our legislators at the grass roots level throughout 2020. Our nation's veterans are depending upon us to do so, many regards.

National Cemetery Administration Suspends Military Funeral Honors

The <u>National Cemetery Administration</u> is suspending military funeral honors – whether by military personnel or volunteer organizations – at its 142 national cemeteries.

The move comes as a precaution to mitigate the spread of COVID-19. Cemeteries will remain open and continue to provide interments for veterans and eligible individuals. Immediate family members – limited to 10 people – will be able to witness from a distance.

The NCA is asking families who wish to postpone a scheduled interment to contact the national cemetery where the interment is scheduled as soon as possible. Those who choose to continue with the interment can work with the NCA to schedule a committal or memorial services at a later date. The National Cemetery Scheduling Office in St. Louis will continue to provide scheduling services for the duration of the COVID-19 emergency. To schedule a burial, call (800) 535-1117, option 1.

Arlington National Cemetery (ANC) closed to the public as of March 13. Funerals will continue, <u>per the ANC website</u>, and family members can visit during restricted hours after obtaining a family pass. Family members can call (877) 907-8585 for information about visitation, ceremonies, or scheduling. Updates will be posted on ANC's Facebook page.



UPDATE from DFAS on SBP-DIC changes

DFAS Retiree Newsletter (March 2020) provided by CAPT Loren Heckelman, USN (ret)

Congress included a phased elimination of the SBP-DIC offset in the 2020 National Defense Authorization Act. The first adjustment to the offset formula will be for January 2021 (paid on February 1, 2021). The offset will be eliminated entirely beginning on January 1, 2023.

Who this change affects

- This change affects surviving spouses who are, or who will become in the future, eligible for both Survivor Benefit Plan (SBP) payments and Dependency and Indemnity Compensation (DIC) payments, and who are subject to the SBP-DIC offset.
- The law also affects the spouses and children of service members who died while on active duty or inactive duty, in the line of duty, if the children are currently receiving SBP payments because the surviving spouse chose the optional child annuity.
- This change does not affect surviving spouses who receive only SBP (but do not receive DIC). It also does not affect spouses who receive DIC only, either because SBP was declined by the service member at retirement or because the service member was a disabled veteran who was not also a retiree.
- It is important to note that this change does not impact any retirees or surviving spouses if SBP spouse coverage was previously declined or if a retiree elected child-only coverage at retirement. The change also does not create opportunities for new enrollment in SBP for retirees who previously declined coverage.

What you need to know

- Surviving spouses who are subject to the SBP-DIC offset will potentially see the first change in their January 2021 SBP payment that is paid on February 1, 2021.
- We are unable to provide individual estimates of the upcoming changes in spouse SBP annuity payments due to this change in the law. Please do not call our Customer Care Center to request an individual estimate.
- If you previously received a refund of SBP premiums paid due to the SBP-DIC offset, you won't need to pay back that refund because of this change in the law.
- Eligible survivors will continue to receive SSIA, up to the prescribed maximum amount (\$323 per month for 2020) or the amount of SBP that is offset due to DIC, whichever is less. SSIA will no longer be paid once the SBP-DIC offset is fully eliminated in 2023.
- Please keep in mind that there are many different situations for individuals, and you may have individual questions we cannot answer yet. We are continuing to develop full implementation guidance for this change.

What you need to do

- You do not need to notify us that your SBP payment is affected by this change in the law.
- The most important action SBP annuitants can take at this time is to ensure your annuity account information is up-to-date and includes your correct mailing address so we can contact you, if needed. Also, if you're not using myPay, set up a profile now and add your email address. Please note: only annuitants who are currently receiving an SBP or SSIA payment from DFAS can access myPay.
- If you are a surviving spouse who previously chose the Survivor Benefit Plan (SBP) child annuity when your spouse died on active duty or inactive duty, you do not need to take any action at this time. You will be contacted by the appropriate military service prior to the annuity reverting to you as the surviving spouse on January 1, 2023.

When you can expect changes

Based on the NDAA, the phases of the SBP-DIC offset elimination are:

- In 2020, surviving spouses will continue to have their SBP offset by the full amount of Dependency and Indemnity Compensation (DIC) they receive from the Department of Veterans Affairs.
- In 2021, SBP will be reduced by no more than two-thirds of the amount of DIC rather than by the entire amount of DIC, even though eligible surviving spouses will continue to receive the full amount of DIC.

Please note that not all surviving spouses will see an increase in their SBP payment in 2021. It is possible that if a spouse's SBP monthly payments are less than two-thirds of the amount of monthly Dependency Indemnity Compensation (DIC), they may not see an increase in 2021.

- In 2022, SBP will be reduced by no more than one-third of the amount of DIC received.
- In 2023, the SBP-DIC offset will be totally eliminated, so that surviving spouses eligible for both programs will receive both SBP and DIC in full, effective January 1 (paid on February 1, 2023).

ANSWERS TO FREQUENTLY ASKED QUESTIONS

Cost and Revenue Share: The Navy plate is a revenue share with **Navy and Marine Corps Relief Society**. NMCRS will receive \$15 annually for every plate sold (after 1,000 initial sales), tax deductible as a charitable contribution.

- 1. Annual plate fee is \$25 for standard series, will start at 1001XX (series letters TBD)
- 2. Annual plate fee is \$35 for personalized plates and must comply with DMV content rules.
- 3. Motorcycles, veteran-owned business vehicles, disabled plates are included.
- 4. For Virginia, plate purchase is separate from registration renewal (decals). New plates may be purchased at any time for a registered vehicle. You may preorder this plate immediately, please do not wait for registration renewal to be due.

Plate approval process: This is a Plate Under Development, subject to the following DMV laws:

- 1. As soon as 450 paid applications are received, our Legislative Sponsor will prepare authorization bill for the next General Assembly.
- 2. General Assembly convenes every January with docket deadline 30 days prior to convening date.
- 3. Approved plate authorization bill will be signed by the Governor in March.
- 4. Bill is enacted into law on July 1st.

Plate development: The entire process takes up to nine months. Once the Governor signs the bill and DMV receives the 450 preorder applications and payment, the plate development process will begin. As a courtesy, the vehicle registration will be renewed if it is within two months of expiration and DMV will bill for payment. Also, applicants with a multiyear vehicle registration will receive a bill for the additional year(s). The new license plates, vehicles registration, and decals will be mailed to all preorder applicants prior to the new plate's statewide availability.


