### Blue Skies and Tailwinds to Former HRCMOAA Chapter President, LtCol James "Rip" Dellaripa, USAF (ret)



James M. Dellaripa, Sr. (Aug 29, 1925 - Jun 19, 2022) died peacefully on Father's Day surrounded by his family. He is preceded in death by his parents, V.J. and Antoinette Dellaripa; sister, Francine; brother, Robert and wife, Indie Jo Inge.

He is survived by his children, Shelley (Jerry) Jensen, Leanna (Jerry) Heeren, Mike (Margaret) Dellaripa; grandchildren, Michael, Adam and Marshall Hyzdu, Christina Salisbury, Chuck Heeren, Michael and Gary Dellaripa; 11 greatgrandchildren and 2 great-great-grandchildren.

LtCol Dellaripa graduated from East Hartford High School and was a Kappa Sigma at the U. Of Connecticut. He joined the Navy during WWII and continued his military career in the USAF flying the F86-F in Europe and the RF4 during Viet Nam. He graduated from the University of Nebraska. After military retirement, he was the City of Richmond Building Commissioner. He retired again and was active in many civic and military organizations.

HRCMOAA was the beneficiary of LtCol Dellaripa's leadership as he served as Chapter President in 2007 and 2008. "Rip" remained active in the chapter after his terms as president, staying engaged with the board and always attending monthly luncheons.

In 1952 "Rip" got his wings from USAF. On June 19th he earned them from God. Please continue to page five for some photos of LtCol Dellaripa over the years.

After breakfast, the group moved to a small meeting room and Rip called the meeting to order. Rip welcomed me warmly and proceeded to introduce me to the board as the chapter's new Secretary!

I've been on the board in one capacity or another since that day and have been honored to serve this chapter with the likes of Colonel Dellaripa and many others. Many of the men I met that first day have passed away since then... and Rip is the latest of that group to have left us. It was an honor and a privilege to know them and serve alongside them. Thank you for your service, Rip. God Speed and may you rest in peace.

drove around, at each turn he exclaimed, "There's a grocery store, a church, a gas station, a bowling alley! This is just like a little town!"

This was his first exposure to a military base. I had not realized what a great experience it would be for him. He was so impressed.

If you are near a base, check online for tours or museums open to youngsters. If that's not possible, look for books about the military at your library. (<u>Military Officer magazine</u> often suggests books to read and has reviews.) You can also watch movies with a military theme. Be sure and check for age appropriateness, though.

Another opportunity is having an overnight party with the grandkids. Bring out the photo albums and scrapbooks. Explain your spouse's role and assignments while in service. Relive some of your overseas adventures. The kids will love it. They'll learn a new dimension of your life and enjoy viewing photos from your youth.

Instill patriotism and love of country in the younger generation. Remind them of their responsibilities and your spouse's and family's history of service and sacrifice. Tell them of the activities of your MOAA chapter and your role in their good works as a member, surviving spouse liaison, board member, or active volunteer. You will be extending that sense of community to the next generation.

Demonstrate and teach them to "never stop serving."

# Military ID Card Notification Program

This voluntary program is designed to help Chapter members and their dependent's to renew their ID cards in a timely fashion. Once you and your dependents are enrolled, you will be notified of your impending ID card expiration date in sufficient time for renewal prior to the expiration date.

To enroll by mail: make copies of the form below for each dependent and fill out the required information. Mail to Military ID Card Notification Program, HRCMOAA, PO Box 4612, Virginia Beach, VA 23454-0612.

To enroll by email: visit our website, www.hrcmoaa.org and click on About Our Chapter and the ID Card Notification Program link and follow the instructions.

Note: Over age 75 members, who are eligible uniform family members and survivors of deceased personnel are now eligible for Permanent Identification Cards. Apply within 90 days of expiration of current ID card.



### VIRGINIA BEACH VETERANS DAY EVENT

CAPT Loren Heckelman, USN (ret)



The Hampton Roads Council of Veterans Organizations (HRCVO) will host the annual Tidewater Veterans Day Parade in Virginia Beach on Friday, 11 November 2022. The parade will begin at 9:00 AM. The parade route this year has changed and will start from the Virginia Beach Oceanfront on Atlantic Avenue and proceed up 17th Street, right turn onto Mediterranean Avenue, then a left turn onto 19th Street pass the Tidewater Veterans Memorial (across from the Virginia Beach Convention Center) ending at the DoubleTree Hotel.

For over thirty years, the HRCVO has been coordinating the Veterans Day Parade and associated events. Each year, one of the HRCVO member organizations co-sponsors the parade. This year the Sons of Confederate Veterans is the co-sponsor organization. In addition to the parade, a short ceremony is held at the Tidewater Veterans Memorial immediately following the parade and a luncheon honoring our Veterans is held at the DoubleTree Hotel at approximately 12:00 PM.

The Veterans Day Parade is sanctioned by the Dept. of Veterans Affairs National Veterans Day Committee and the Mayors of Chesapeake, Norfolk, Portsmouth, Suffolk and Virginia Beach who sign a proclamation resolving that "citizens, businesses and organizations demonstrate due appreciation, admiration and respect for all veterans who have served our great nation".

Following the parade, there will be a ceremony at the Tidewater Veterans Memorial and a Luncheon at the DoubleTree Hotel.

The Hampton Roads Chapter of MOAA has been invited to participate in the parade and the luncheon. We must submit our application for parade participation no later than 1 October 2022 to the HRCVO Parade Coordinator.

The Hampton Roads Chapter of MOAA has also been invited to attend the Veterans Day Luncheon at approximately 1200 (or immediately following the Memorial Ceremony at the completion of the parade). The luncheon will be held at the Double Tree Hotel, 1900 Pavilion Drive, Virginia Beach, Virginia and the price is \$25.00 per person. Tickets are sold in advance and must be presented at the door. If a number of people from the chapter want to attend and sit together, we can coordinate as a group and purchase a group of tickets. Otherwise, RSVP separately by 30 October to 757-663-1495 and make your check payable to Hampton Roads Council of Veterans Organizations.

### Community Affairs - Hampton Roads Chapter ROTC Scholarship Fund

The MOAA Scholarship Fund Board gives preference in awarding scholarships and grants to children with HRCMOAA chapter member parents. While not guaranteed to go to the child of a chapter member, those children applying for MOAA scholarships with a parent who is a chapter member will receive favorable consideration and the review board will give preference in awarding scholarships to those children. Regardless of whether the student's parent is a chapter member or not, students selected for MOAA scholarships in the chapter name will always be from the area represented by our Hampton Roads Chapter. Note on your check that it is for the Hampton Roads Chapter ROTC Scholarship Fund. MOAA will continue to send receipts.

A **third** way is to contribute directly from bequests, wills, trusts, or IRA's. The fund tax identification number is 54-1659039. By contributing from the Required Minimum Distribution (RMD) of a qualified IRA, the taxable IRA income can be reduced by the amount of the contribution. The contribution check must be marked as a charitable contribution. With the change in the tax laws last year, some of our members have found this method to be beneficial. For additional detail, it would be best to contact your IRA fund manager for specifics relating to your IRA.

# Military Retirees & Dependents With ID Cards That Don't Expire Need to Get Replacements Within 4 Years Military.com | By Travis Tritten (travis.tritten@military.com)

Retirees and military family members who have identification cards with no expiration date can choose to upgrade to the new Next Generation Uniform Services Identification, or USID, cards whenever it's convenient -- as long as it's done within the next four years, according to the Defense Department.

There is no looming deadline for use of those old non-active duty cards without expiration dates, but the department expects to completely phase out and replace them with the next-generation IDs, which are more durable and have enhanced security features, by 2026, Maj. Charlie Dietz, a spokesman, told Military.com.

In the meantime, cards with expiration dates are required to be replaced within 90 days of elapsing. The Defense Department began the effort to update all those IDs to the new format in July 2020, but the changeover hit delays caused by the pandemic.

"DoD plans to phase out and cancel the existing card forms in 2026 when all existing cards with an actual expiration date will have expired," Dietz wrote in an email. "After then, only the USID card will be accepted for installation and benefits access."

The USID format for military retirees and dependents represents the first change to those identification cards in nearly 30 years; the last update was in 1993. The new design closely resembles the Common Access Card, or CAC, format issued to active-duty troops and department civilians.

But there was uncertainty among those with cards that list the expiration as indefinite. The IDs are needed to access military facilities and to confirm eligibility for various military benefits, so missing a deadline or losing the identification could disrupt cardholders' lives. Expired cards can be confiscated at base gates.

Those with cards with no expiration dates "may have the card replaced at their convenience," according to Dietz. The department recommends they go to the ID Card Office Online and use the office locator to find a site that issues the new cards and book an appointment.

Retirees and their dependents, dependents of active-duty troops, reserve members and Medal of Honor recipients are among those who will receive the USID cards. A description of the new cards and a complete list of who is eligible can be found here. At the onset of the pandemic in April 2020, the Defense Department extended the deadlines for replacing expiring cards in an attempt to keep the military community from gathering in issuance offices and spreading COVID-19. By February 2021, more than 200,000 of the new IDs had been issued.

"Social distancing and other pandemic safety precautions at DoD ID card sites worldwide has delayed the progress of existing card replacement, but generally most of those cardholders who needed to replace an expired card have done so," Dietz said Wednesday.
