2013 MEMBERSHIP APPLICATION AND CONTRACT

This application and contract, dated _____, certifies that I have applied for membership to the Pembroke Meadows Recreation Center in compliance with the provisions of the Civic League of Pembroke Meadow, Inc., and the terms set forth below.

ANNUAL MEMBERSHIP FEE This fee must be received in full prior to distribution of member user passes. Below is a description of the membership options provided. Please read closely to determine which membership category you qualify for.

Membership category	Description
Family	A family pass applies to the male and/or female adult (responsible party) and dependent children permanently residing in the home, in shared custody of, or currently attending college.
Family – Grandparent¹	A family grandparent pass applies to the male and/ or female grandparent (responsible party) and grandchildren ages eighteen (18) and younger.
Family - Single-Parent² (Single parent + one child)	A single parent family pass applies to <u>one</u> adult (responsible party) and one dependent child permanently residing in the home, in shared custody of, or currently attending college.
Family - Single Grandparent² (Single Grandparent ¹ + one grandchild)	A single grandparent pass applies to <u>one</u> adult (responsible party) and one grandchild age eighteen and younger.
Individual	Applies to one individual person eighteen years and older.
Individual senior citizen*	Applies to one individual senior citizen ages 62 and above.
Lifetime Family	A lifetime family membership was offered one time only in 1992. Only existing lifetime members qualify for this category. The membership applies to the adult male and/ or female (responsible party) and all dependents that are: (1) permanently residing in the home, (2) under shared custody, or (3) currently attending college. <u>Grandchildren do not apply</u> to this membership unless they permanently reside in the home. The membership includes two (2) guest cards to be used by persons who do not meet the above requirements.
Capital Campaign Family	Various Donations levels are available. Lifetime membership with a \$10,000 or \$5000 donation. Two year memberships are available with a \$2500 donation and a one year membership for a \$1000 donation. Each capital campaign membership has other items that are included in the membership cost. ** see addendum for further details**
Small Business/ Corporate Membership	A variety of membership options are available. See addendum for all the details.

1. **Grandparent** is defined as a person(s) with one or more grandchildren who they would like to include on their family pass for regular use of PMRC facilities. Grandparent does not fall into the senior citizen discount category if 61 years of age or younger.
2. The “**Single Parent**” and “**Single Grandparent**” family memberships are intended for use in households with only one resident parent. Two-parent households do not qualify for these categories.

GUEST PASSES

A *regular guest pass* can be added only to a *Family* or *Family Grandparent membership* for a \$75 fee. This pass pertains to a family member not residing in the household, the member's child care provider, a child regularly cared for in the home, or a non-family member residing in the household.

The regular guest must be accompanied by the sponsoring family and remain with guest. Limit two (2) guest passes per family membership.

A *guest punch card* can be purchased for \$30 by a family or family grandparent membership. This pass entitles a current member family in good financial standing 10 passes for guest use at a discount of \$3 per visit. **The guest must be accompanied by the sponsoring family and the member must remain with guest until both leave the pool.**

A *Daily Pass* can be purchased for \$5 per guest. This pass is good for a one-day visit to PMRC. A daily pass can only be purchased by current members for their guest/s. **A current member must accompany the guest to the pool and remain with guest.**

POOL PARTIES

There are a variety of options for your family to host a pool party at Pembroke Meadows Recreation Center during the day and after hours. **All parties must be reserved in advanced so adequate preparation can be made.** Contact the guard office for application forms and more information on fees and scheduling.

SWIMMING LESSONS

Swimming lessons are available to member and nonmember families for a fee in the month of JULY. Each child is provided with five (5) swimming lessons taught by certified lifeguards. Contact the guard office at the opening of the season for more information.

PAYMENT PLAN

PMRC now has a payment plan option. There are no carrying charges, and an early payment discount applies, if paid in full by April 30th. If you choose to use this service the following stipulations apply:

- The joining member must provide a minimum down payment of \$50.
- The entire membership must be paid for in full by opening day in May (Memorial Day weekend)
- \$100 is non refundable if membership is cancelled before opening day or membership dues are not paid in full.

In the event that the applicant defaults in carrying out the terms of this contract, any monies paid prior to the time of default (up to \$100) are forfeited and no claims shall be made by the applicant against the Civic League of Pembroke Meadows, Inc. At the option of the Pembroke Meadows Recreation Board, the applicant's membership may be considered null and void.

Membership cards will be available for pick up on opening day at the pool.

Referral refunds are calculated at 10% of the membership fee of the new member. Ex: new family membership would entitle referring member a referral refund of \$42.50. There is no limit to referral refund fees.
