# OLD DONATION PARKWAY:

Subsequent to the successful deletion of Old Donation Parkway from the Master Street and Highway Safety Plan, U C A P (United Citizens Against the Parkway) was disestablished. The Civic League commends Russ Dickens, UCAP President, and Joe Avoli (our representative to UCAP) for their superb efforts. The letter on page two of this Newsletter was received from Russ Dickens:

To all the officers and members of United Citizens Against the Parkway,

It gives me great pleasure and also some sorrow to write this letter. It gives me great pleasure for the obvious fact that we have now achieved our goal. Old Donation Parkway has been deleted from the Master Street and Transportation Plan. The reason for some sorrow of course is the fact that although it is all over, there is a certain feeling of finality in the many very nice friendships that have been nurtured during this long battle.

It certainly is great to know that our system does function, but it takes a great deal of work and patience. I would like to share with all of you who did so much, the glory, the thanks and the many accolades that have been passed to me and really belong to all of you. As you realize there is no one person that can do everything by himself of that magnitude. It takes the support of a lot of people. nswer to ROAD HAZARD:

We certainly concur that the narrowing of Pembroke Boulevard with no warning to motorist's presents a

traffic hazard.

Mr. Bill Gray of the Virginia
Beach Traffic Engineer Department
was contacted on 30 March. It
was recommended to Mr. Gray that a
"Road Sign" stating "ROAD NARROWS"
be erected on the right hand road—
side along with a luminous arrow
appropriately placed to warn
motorists. Mr. Gray concurred with
the hazard and promised dispatching
an engineer to the sight to determine
the appropriate corrective action
necessary.

Answer to FENCE REPAIR:

We often get questions about the fence between the shopping center and the Townhouses, since they are in such a state of disrepair.

The fence was originally constructed

ilt the townhouses. However, when the fences began to need repair, the Civic League contacted Terry Corp. and was told that the fences were on private property and, as such, were to be maintained by the owners.

A subsequent check revealed that an error had been made in the construction of the fence. From approximately the north corner of Safeway to Witchduck, the fence had been erected on the land included in the Pembroke Meadows Shopping Center, which is owned by the Berry-Robinson Home for Boys. That section of fence was repaired by them.

The other residents were offered the opportunity to have their fences repaired at "reduced cost". The "reduced cost" was exhorbitant and all owners refused.

Those fences which need repair are the responsibility of the owners, some of whom are absentee landlords. The Civic League has no control over these repairs.

Answer to BARKING DOG":

Article 5-36 of the City of Virginia
Beach Code addresses dog owner responsibility in regard to ensuring that their pet does not become a nuisance to neighbors

The code stipulates that no pet shall cause excessive noise, destroy property harm persons, etc.; and generally protects neighbors against pets becoming a nuisance.

The Civic League by-laws were also voted upon. The results of the vote were for adoption of the by-laws as written and distributed to all residents. A major discussion ensued about the adoption of the Recreation Center Annual Budget as written in the by-laws. The by-laws specify that the general membership approves the Recreation Center budget. Opinions were expressed that only Recreation Center members should approve the budget. CURRENT STATE LAW require that non-profit organizations maintain one (1) financial organization. Hence, the Civic League membership must be responsible, accountable, and the authority in financial matters. Such is quite easily accomplished by mature, interested and responsible adults. We must bear in mind that the Civic League must work toward meeting the needs of all residents. As such it must meet the needs of Civic League members , Recreation Center members and other residents. The Recreation Center is an integral




