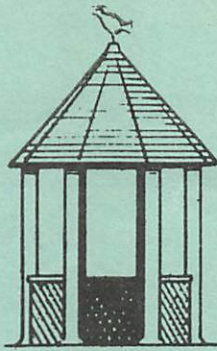

BICYCLE SAFETY PROGRAM

V.F.W. Post 392 and its Ladies Auxiliary will hold a LITE-A-BIKE Safety Program on the Murphy Mart parking lot on Saturday, 17 November 1979 from 1:00 p.m. to 5:00 p.m. The purpose of this program is to place reflective tape on individual bicycles and to perform a safety check on each bicycle. Additionally, there will be a skills test covering eleven different aspects of bike control. Participants will be judged according to 3 age groups, ages 8-10, 11-12, and 13 and over. Trophies will be awarded in each age group to the three top participants. We will be assisted in this program by the Va. Beach Police and Police Auxiliary and the McDonalds Corporation. Come on out and bring your bikes. Parents are invited to have their bikes checked and taped also. A rain date of November 24, 1979 has been set.

Your Rec Center Pool pumps were secure the evening of Labor Day the '79 season came to a close. Efforts of a number of dedicated people combined to ensure that the Center ended its '79 season in the black. The '80 Board will have a great deal of usage data and history on which to base its decisions. Documentation is an absolute necessity for sound financial management of an operation of this kind.

In accordance with the new Civic League by laws adopted last spring the Rec Center '80 budget and a financial statement dated 10-31-79 is hereby submitted to the full membership. The proposed budget is a combined effort of this and next years Board. It was felt that the '80 Board would have to live with an approved budget so they were appointed to act in the capacity of an advisory financial committee.

In December of this year there will be an audit of the '79 books. The Audit Committee consists of Jack Enoch, Jerry Noah and Alton Mercer. On January 1st the new Board will take over. The '79 Board wishes them success and urges all members to support them and their decisions.

Dear Neighbor:


