PROPOSED AMENDMENTS TO THE BY-LAWS OF THE CIVIC LEAGUE OF PEMBROKE MEADOWS. INCORPORATED

The Recreation Committee has proposed amendments to the By-Laws to restructure the categories of membership of the Recreation Center. In the future, if the proposal is approved by the Civic League, all residents of our community, both homeowners and renters, and all non-residents will have <u>essentially</u> equal status with respect to membership in the Center. This includes the equal payment of Center dues, the right to vote in Center affairs, and the right to hold office in most positions on the Recreation Committee. Additionally the proposed amendments will simplify the approval procedure for special assessments when required.

The proposed amendments are hereby published as part of this newsletter and will be presented to the membership of the Civic League for vote at the January. 1981 meeting. Current By-Laws can be made available for review by contacting Civic League President, Gary Romska at 497-6552, or Charles Russ at 497-5298.

Proposed Amendments to:

ARTICLE XV - GOVERNING POLICIES AND OPERATING PROCEDURES OF THE RECREATION CENTER

3.1 - Membership

- b. Membership shall consist of no more than three hundred (300) families. Change to read:
 - "b. Total membership during each year will be determined by the Recreation Committee and approved by the Civic League Board of Directors. Total memberships will be determined by consideration of all factors attendant to pool operating requirements. Final acceptance of families/individuals for membership will be on a first come first serve basis."
- c. There shall be five (5) categories of members: Delete this and the explanation of the categories. Change to read:
 - "c. There shall be three (3) categories of memberships:

CATEGORY I - FAMILY To include Pembroke Meadows homeowners, former homeowners wishing to maintain membership, renters, and non-residents. Membership shall apply to the male and/or female adult and all dependents permanently residing in the home.

CATEGORY II - INDIVIDUAL To include the same personnel as in Category I except that membership shall apply to only one person. The annual dues shall be computed as one-half (½) of Category I membership rounded to the nearest whole dollar. An individual membership cannot be transferred, loaned, or sold to another person.

CATEGORY III - INACTIVE To include any Category I and II member in good standing who request in writing to the Recreation Committee prior to 1 May of the pertinent calendar year, a waiver of annual dues based on extenuating circumstances. For the period requested, the member will not be required to pay annual dues but will not be authorized to vote or take part in any privileges offered a paying (full) Recreation Center member."

- e. All memberships are of one type: FAMILY, to include the male and/or female adult and all dependents permanently residing in the home. Delete in entirety.
- 3.2.b. Voting memberships will be limited to members of the Civic League of Pembroke Meadows, Incorporated and shall be filed with the Director of the Center on forms provided by the Recreation Committee. Membership is conferred by approval of the application by the Recreation Committee. Change to read:

"3.2.b. All Category I and II members who are Pembroke Meadows homeowners or renters must be bonafide members of the Civic League of Pembroke Meadows, Incorporated as defined in Article III of these By-Laws. Said members will be authorized to vote on any Civic League or Recreation Center matter.

Members who are non-residents of Pembroke Meadows must be part-time members of the Pembroke Meadows Civic League and will have limited voting privileges. Members will only be authorized to vote on matters pertaining to the Recreation Center and will pay only a prorated share of the Civic League annual dues computed at 25% rounded to the nearest whole dollar."

- 3.3 Delete the "A" after Category I in the last sentence.
- 4.5 Membership Initiation Fee
 - a. Each family unit shall pay a one-time membership initiation fee which shall apply to only one residence. If leaving the area for an extended period, membership may be placed in "Category V" (Inactive upon written notification and acceptance by the Recreation Committee). Change to read:
 - "a. Category I and Category II memberships shall pay a one-time membership initiation fee which shall apply to only one residence. If leaving the area for an extended period, membership may be placed in "Category III" (Inactive upon written notification and acceptance by the Recreation Committee)."
- 4.6.a. Delete "family unit" and add "Category I and Category II memberships."
- 4.6.c. In the sixth sentence, change "Category V" to "Category III".
- 4.7 2 dt Special Assessments of of anthrate boog of redmen II

Special assessments, if any, are subject to the approval of the majority of the Recreation Center membership. They shall be payable at such time as specified by the Recreation Committee.

Change to read:

"Special assessments, if any, are subject to approval by a two-thirds (2/3) majority of the Recreation Center quorum present including proxy votes. They shall be payable at such time as specified by the Recreation Committee."

Vortag memberships will be limited to members of the Civio heague of Pembroke Meadows, Incorporated and shall be file with the Director of the Center on forms provided by the Recreation Committee. Membership is conferred by approval of the application by the Recreation Committee.
