NEIGHBORHOOD WATCH ALERT

Recently, Pembroke Meadows residents experienced unfortunate vandalism. Reports by residents whose vehicle windows were randomly broken prompted our Watch program into action. Because residents notified the Neighborhood Watch Coordinator, who in turn called the Block Captains, many more residents were made aware of the situation. Outside lighting was turned on at some households and people were "watching" activity among the streets. This is Neighborhood Watch in process! Please remember to: 1) always report suspicious or criminal activity and 2) alert your block captain as soon as possible. HOW DOES THE CIVIC LEAGUE SERVE OUR **COMMUNITY?**

General meetings, held on the third Thursday of each month (except December and summer months) at Pembroke Meadows Blementary School cafeteria,

provide a forum for community members to voice concerns and develop area enhancement activities. The Civic League sponsors family centered social programs including Halloween Walk, Christmas "Tree Trimming" narties, and Pot Luck Dinners. Working in concert, the Recreation Center and Civic League members organize building and grounds clean-up and maintenance twice a year. Communication services such as the monthly newsletter and resident directory are invaluable sources for networking neighbors together. The "Median Watch" program provides a means to keep our entrance attractive and property values competitive. Neighborhood Block Security programs are proven methods that reduce criminal activity and promote a safer environment for everyone. The local Boy Scout Troop and school band groups have received Civic League support. When street lights burn out and sidewalks require repair, the Civic League coordinates work orders with various city departments. The Wayside Park is the proudest of accomplishments! Which would you prefer - our beautiful park, with improved sidewalk access to the pool, landscaping, and recent bike path addition or a through road which limits safe passage for children, coupled with increased traffic and criminal activity? Your Civic League insured that the better choice was the choice we got.

Through efforts made by our Civic League members, our Recreation Center has been lawfully redefined as a benevolent organization, resulting in personal property tax exemption. This means that membership dues can continue to be kept at a very reasonable rate.

The Civic League makes every effort to identify and acknowledge grieving residents who are coping with loss of family members. Also, welcoming services are offered to new residents. When city planning development is close to home, the Civic League is a vital body which acts to promote the best interests for area residents. In short, this community is among the few remaining "across the county" to reap the benefits produced through our Civic League. You show support by paying dues (\$8 year), attending meetings, and getting involved. Helping the Civic League ultimately benefits you and your family!


A REQUEST FROM A TEENAGER

DEED RESTRICTIONS

A homeowner recently appealed to the Civic League with a request to make a property improvement that is not in conformance to the deed restrictions (For your information, the deed restrictions are listed in the front of the 1992 Neighborhood Directory.) Since deed restrictions are in fact restrictive covenants on land use that convey with the deed (from owner to owner) these restrictions are enforceable by property owners and can be changed only with the approval of a majority of those property owners. Neither the Civic League nor the Board of Officers has the authority to change the deed restrictions. Homeowners who have made property improvements that are not in conformance with the deed restrictions have done so at their own risk. Please let me state this again: your Civic League simply does not have the power to grant requests which are not in conformance with the deed restrictions.
