Boat launch/access at our park or recreation center? The City's new Draft Outdoors Plan recently published (copy available at the library) is interesting reading and projects a proposed intention to preserve and enhance open spaces, parks, recreation areas, etc. throughout Virginia Beach. However, on page 25 of that draft plan is a specific "High Priority" plan to locate a "public waterway access to the Western Branch of the Lynnhaven River" at "Pembroke Wayside." The accompanying small-scale map depicts the proposed location at/near our recreation center and park.

Our Civic League has expressed concern about the location (which apparently is on or abuts Civic League property), and we have requested clarification and specific information concerning that plan. The City's Parks Department has reassured us that no specific plan has been developed for such a possible boat launch/access there, that the initial idea envisioned only non-motorized small boats/canoes, and no specific plans or development would ensue without our Civic League's concurrence.






