LOWES VS TARGET?

Just in case you are interested, I did some research on the vacant land where Giant Square and Farm Fresh used to be. As you recall at the last civic league meeting, it was suggested that Target was possibly going to build a store there.

There is nothing in the Virginia Beach Real Estate Records to support this story:

In December 2007, the plot occupied by Farm Fresh was registered to the following address:

PO BOX 1111 NORTH WILKESBORO NC 28656-0001

The VAB records do not name the owner, but a Google search shows this is the address of Lowes company offices.

There are no records on file to support a sale or transfer from Lowes to Target. Target Corporation is a Minneapolis-based company.

Since the VAB records do not reflect a change of ownership from Lowes to anyone, we must conclude that speculation about a Target store is an unsubstantiated rumor.

Other tid-bits of information:

The entire Giant Square/Farm Fresh parcel was purchased in 1985 for \$3,419,735.00. Lowes purchased it in 2007 for \$13,500,000.00. This encompasses what was once Avalon Cleaners all the way to C&M Cafeteria, the parking lot and all land where the strip of small shops were on the South side.

The site of the old gas station on the Northeast corner apparently is not part of the Lowes parcel and is registered to Realty Advisory Group Incorporated, 1213 Laskin Rd, VAB. The status of this plot is uncertain, but we can probably assume that Realty Advisory Group is a holding company for various commercial business properties. In general, corner parcels are not part of a typical Lowes development and are often occupied by fast-food restaurants, quick-stops or equivalent.

The site of the Dunkin Donuts shop turned Mexican restaurant is part of the Lowes purchase.

The Bank of Hampton Roads sits on land that is part of the Lowes purchase. Apparently, the bank continues to lease this location from Lowes.

Red Lobster restaurant is not included in the Lowes purchase and is registered to a PO Box in Orlando, FL. Not surprisingly, Orlando, FL is the corporate home of Darden Restaurants, which owns all Red Lobster restaurants.

The property where the Yukon Restaurant once stood, belongs to Lowes, but is registered under a different Lowes address, so probably was purchased separately from the Giant Square acquisition.

The Independence Veterinary Clinic (originally Twin-B Auto Supply) is registered to a Chesapeake address for the Independence Veterinary Hospital, so is not included in the Lowes property.

Finally, the status of the Hardee's fast-food restaurant is uncertain. It is registered to Pembroke Commercial Realty Corporation, Virginia Beach. Most likely they are a holding company for various properties leased to businesses of this type. As a corner property and a plot geographically separated from the main Lowes parcel, it is probably safe to assume it is not being considered as part of the overall plan.

And now you know the rest of the story.
